Farmers markets are essential partners in creating market opportunities for farmers and fostering local food economies; engaging communities as shoppers and volunteers; activating downtowns, educating the public about food, agriculture, and healthy eating, as well as addressing food insecurity in Washington State. This report summarizes the statewide “vital statistics” for farmers markets by year.

Data is from the WSFMA unless otherwise noted. Individual farmers market organizations (FMO) provide prior year data by farmers market (FM) to the WSFMA with their annual membership application. Reported data is then cleaned and aggregated by the WSFMA. In 2025, 97% of member markets reported prior year data (n = 104).

Thank you to each and every farmers market for diligently collecting and reporting vendor sales and other vital market information. This work directly helps to inform policy makers, funders, partners, and others about the economic and community impacts of Washington State farmers markets.

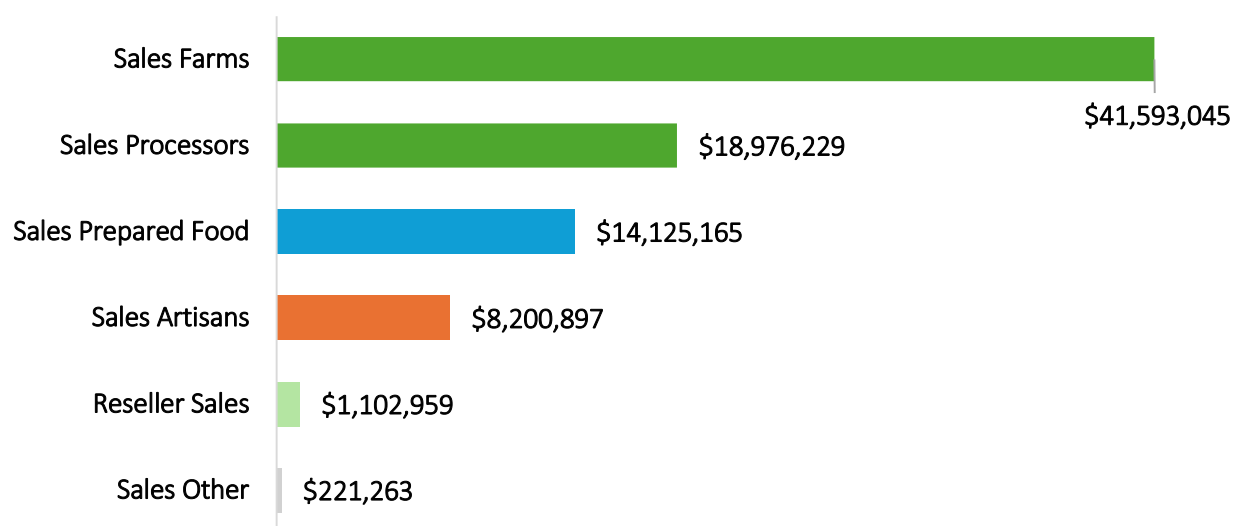

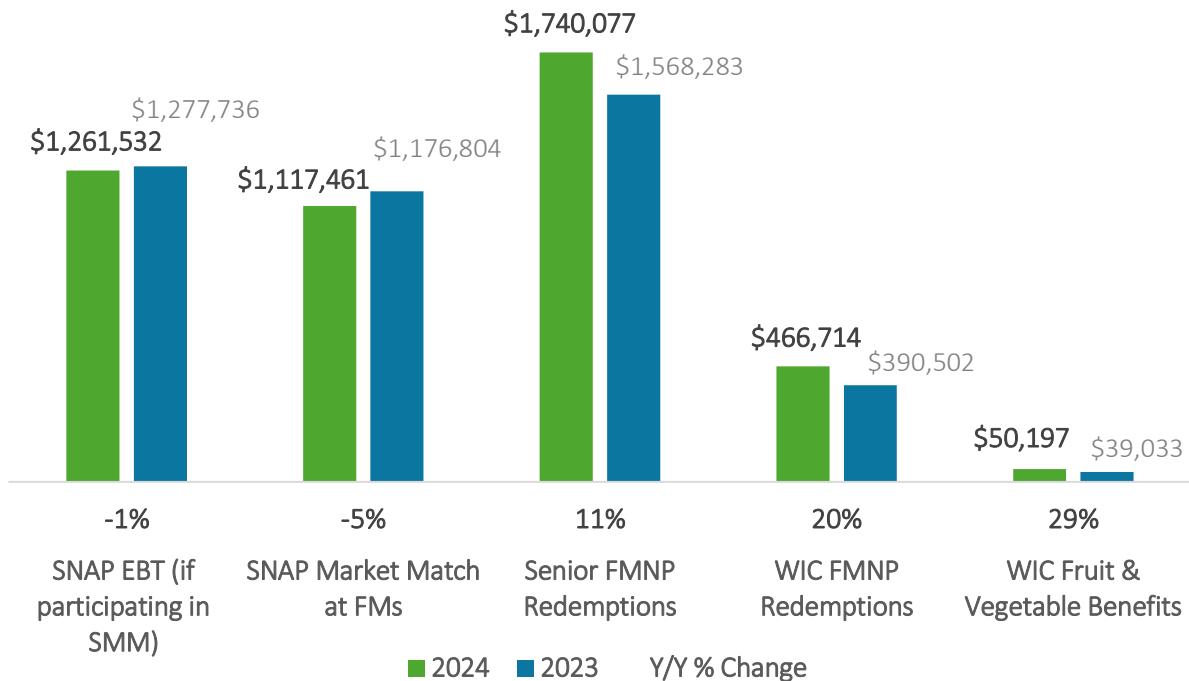

Food Access Programs

In 2024, families spent a reported \$4,635,981 in food access benefits at farmers markets to buy fruits, vegetables, and other foods directly from Washington farmers and food businesses. This represents 5.5% of all reported vendor sales at farmers markets.

While Supplemental Nutrition Assistance Program (SNAP) is the most frequently recognized public food assistance program able to be used at farmers markets, the Farmers Market Nutrition Program (FMNP) is the largest. FMNP is also only able to be used for five months a year, from June to October. Mirroring national trends, SNAP spending at farmers market has declined year over year, along with its companion incentive program called SNAP Market Match¹. FARMERS MARKET ORGANIZATIONS

Farmers market organizations are incorporated in a variety of ways. They are responsible for setting policy, raising money, hiring a market manager and seasonal staff, recruiting volunteers, ensuring compliance with food safety, insurance, and other financial responsibilities, as well as administering food access programs, planning promotions, managing vendors, and ensuring the smooth market day operations.

FIGURE 3. Farmers Markets by Organizational Incorporation (n=103)

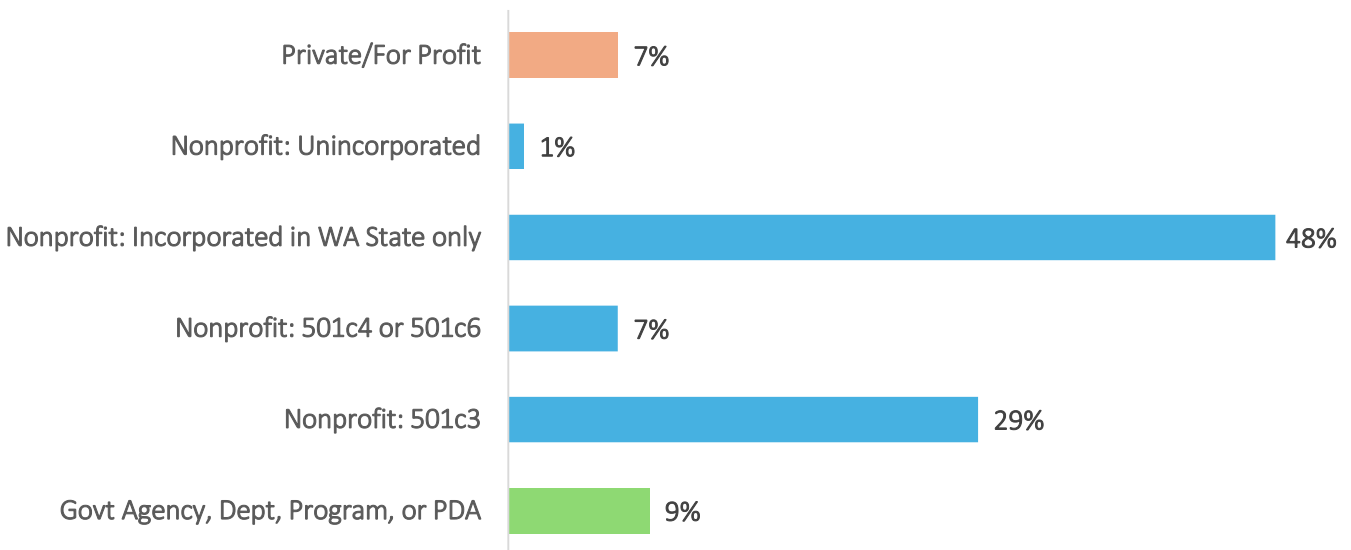
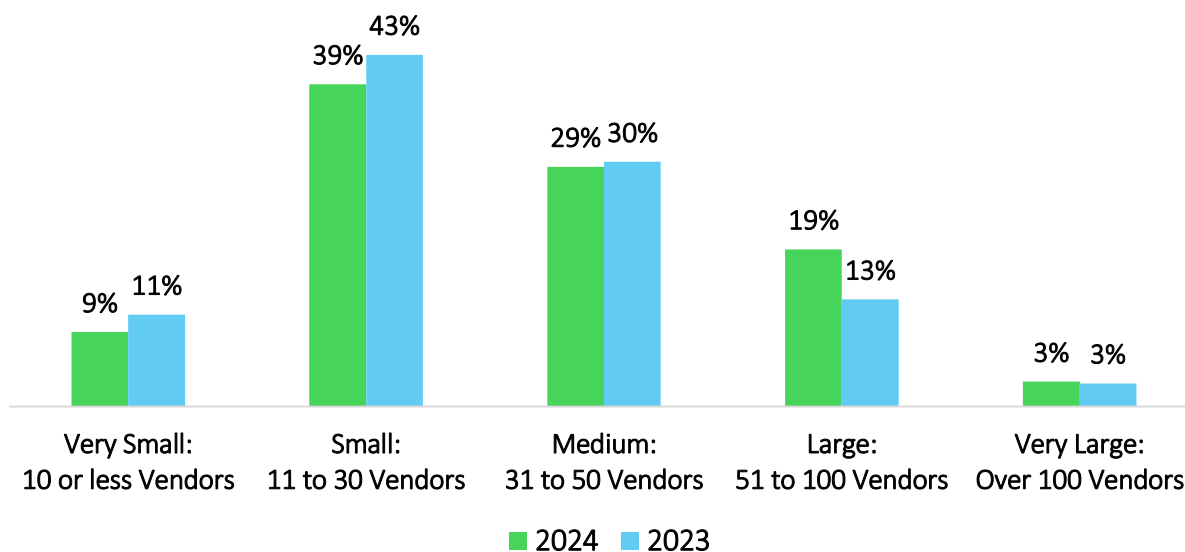


FIGURE 4. Farmers Markets by Market Size. (Based on Average Number of Vendors during Peak Season) (n=99)
